



WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of my participation in the _____ and/or related events or activities (collectively, the “Event”), I hereby waive, release and forever discharge any and all rights and claims and damages which I may have or which may hereafter accrue to me and every child and guest accompanying me against The Greensboro Area Chamber of Commerce, Inc., a North Carolina nonprofit corporation, as well as all other promoters and sponsors of the Event, and each of their respective officers, employees, volunteers, agents, and representatives (the “Released Parties”) arising from or otherwise related to traveling to, participating in or returning from the Event. This release includes any bodily injury, personal injury, exposure or potential exposure to any illness or virus, including the novel coronavirus (“COVID-19”), whether caused in whole or in part by the negligence, fault, or other misconduct of any of the Released Parties.

I understand that my participation in the Event and use of Event facilities carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. I further understand that the Released Parties, regardless of any precautions taken to reduce the spread of COVID-19, cannot guarantee that I will not become infected with COVID-19 by participating in the Event. I understand that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to the Released Parties and other Event participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury or illness for myself and every child and guest accompanying me.

I attest and acknowledge that I am not currently and have not exhibited for the last 14 days any symptoms of COVID-19, including, but not limited to; fever above 100.4 degrees Fahrenheit, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea. If I have any such symptoms, I agree that I will immediately notify Event organizers and will not enter or participate in the Event.

I also attest and acknowledge that:

- I have not quarantined in the last 14 days, nor have I been in close contact with someone I have known who tested positive or had to be quarantined.
- I have not traveled internationally within the last 14 days.
- I have not traveled to a highly impacted area within the United States in the last 14 days.
- I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19 within the last 14 days.
- I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

If I am at increased risk of exposure or contacting COVID-19, I will consider not participating or attending this event and assume the increased risks to myself as a result of participation and/or attendance.

As far as practicable, I agree to observe the following measures to protect myself and others while participating in the Event and any related activities: (1) wear a face mask or other covering anytime I am in close proximity to other persons not of my immediate family during the Event; (2) keep at least six feet of

distance between myself and other persons not of my immediate family whenever possible; and (3) wash my hands before and after using the restroom, preparing/consuming meals, providing services to others, or touch a surface or item that is to be used by others.

I further agree to protect, defend, indemnify and hold harmless the Released Parties from and against any claim, demand, action, cause of action, or lawsuit, and any liability, cost, expense, damage, or loss, including court costs and attorney's fees, for claims against myself or the Released Parties that arise from or are alleged to arise from my participation in the Event.

By signing below, I (personally and on behalf of every child and guest accompanying me) hereby accept and agree to the terms and conditions of this waiver and agreement. BY SIGNING BELOW, I FURTHER ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS WAIVER AND AGREEMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS.
